

#### A SWAMP OF CONTROVERSY IN COLLIER COUNTY

#### Meet the Siblings Running Against Each Other for the Florida State Senate Seat

**Nationwide** — Siblings Randolph Bracy and LaVon Bracy Davis are competing against each other in a Florida special primary election for a state senate seat once held by Geraldine Thompson. Both have political experience and come from a family deeply rooted in public service and civil rights activism.


The seat became vacant after Thompson died earlier this year. She was not just a political figure but also a close family friend. Their mother, LaVon

Wright Bracy, a well-known civil rights activist, was the maid of honor at Thompson's wedding.



According to the Associated Press, this is not the first time politics has come between the siblings. In last year's Democratic primary for the same seat, Bracy Davis endorsed Geraldine Thompson over her brother. Now, they're competing head-to-head.

The winner of the Democratic primary will go up against Republican Willie Montague in the general election. The district is heavily Democratic, with Black voters making up more than half of its registered Democrats, making the outcome of the primary especially important.

## Turning Ideals Into Action for a More Sustainable Naples

We live in a time when our values and our actions do not always align, especially when it comes to sustainability. Nationally, it is estimated that 75 percent of the American waste stream is recyclable, yet only about 30 percent is actually recycled. Here in Collier County, which includes the City of Naples, we are proud to have achieved a 75 percent recycling rate in 2021, one of only five counties in Florida to reach this milestone, according to the Florida Department of Environmental Protection. This success reflects a robust residential recycling program and award-winning initiatives like foam recycling.

To me, sustainability is not just an environmental concern. It is a civic one.

Sustainability is not a trend or a marketing term. It is a civic mindset grounded in stewardship, accountability, and community. When we allow sustainability to become symbolic, something left to packaging engineers or labeled products, we miss the opportunity to strengthen our civic culture. We trade meaningful participation for performative virtue.

But there is a better path forward, and we have the tools to walk it.

Policy measures like Extended Producer Responsibility laws, which hold manufacturers accountable for the full lifecycle of their products, are promising. Yet laws alone are not enough. True change begins with us, with residents, neighbors, and families who commit to making small but consistent contributions to the greater good.

Imagine if every household in Naples made just one more environmentally conscious decision each week. Small efforts, multiplied across a community, can lead to real and lasting impact.

Are you composting food scraps or yard waste instead of sending them to the landfill? Reusing household items instead of discarding them? Avoiding single use plastics or switching to reusable containers and bottles? Participating in local cleanup efforts or helping protect our beaches and waterways? Choosing to bike or walk to nearby destinations instead of driving?

This is not about regulation for its own sake. It is about reweaving the social fabric. It is about building a culture in

which we are not just consumers, but citizens, people who take responsibility for the communities we love.

Here in Naples, where our natural beauty and quality of life are central to who we are, we have an opportunity to lead by example.

And we are leading.

The City of Naples has taken significant steps to embed sustainability and resilience into our operations and long-term planning:

- We adopted a Multi Basin Stormwater Master Plan in March 2024, designed to improve water quality, reduce flood risks, and modernize critical infrastructure.
- The 2024 to 2029 Capital Improvement Plan, approved in October 2023, prioritizes investments in climate resilient infrastructure such as seawalls, drainage systems, and expanded green public spaces.
- Naples secured 35.5 million dollars in state appropriations in alignment with our legislative priorities, including substantial funding for water quality and flood mitigation projects.
- We launched the design phase for Basin IV stormwater improvements, vital projects for shoreline protection and community safety.
- Beach renourishment efforts, including the full restoration of Park Shore Beach in April 2025, help protect fragile coastal ecosystems and guard against erosion.
- Through focused conservation, we permanently preserved 104 acres of coastal land through the Naples Beach Club conservation easement, recorded in October 2024.

These are not just projects. They are expressions of our core values in action.

Shared responsibility, especially around something as tangible as waste, can be a powerful unifier. It reminds us that our actions matter, and that together, we can protect what makes Naples special.

Let us move beyond aspiration and into action, one household, one habit, one week at a time.

To every small business owner, every faith leader, every teacher, every parent, every student, and every hardworking neighbor in SWFL: I see you. I hear you. And I am with you.



#### As People of God, Coming Closer to God's Heart

July is a wonderful month filled with various events, religious celebrations, and moments of historical significance. Here are some highlights:

In July, several Christian and national feasts are celebrated both patriotic and deep theological themes.

- **July 3rd:** The Feast of St. Thomas the Apostle also known as "the doubter." He became a major evangelist for the country of India. According to tradition, he traveled to the Indian subcontinent around 52 AD and preached the Gospel in the regions of Tamil Nadu and Kerala. He is credited with establishing Christian communities and converting large numbers of people to Christianity, including both Jews and Hindus. This significant contribution earned him the title "Apostle of India."
- **July 11th: The Feast of St. Benedict.** Benedict of Nursia, born around 480 AD in Nursia, Italy, is widely recognized as the founder of Western monasticism. He is best known for establishing the Benedictine monastery at Monte Cassino and for writing the Rule of Saint Benedict, which became the foundation for monastic living throughout Europe and the world. He is considered the patron saint of Europe.
- July 22nd: The Feast of St. Mary Magdalene, also known as Mary of Magdala, is a significant figure in Christianity. She is primarily remembered for her role in the New Testament as the first Follower of Jesus who traveled with Jesus and supported his ministry, second as a Witness to Jesus' Crucifixion: because she was present at the crucifixion of Jesus, witnessing his suffering and death on the cross, third as a Witness to Resurrection: she is most famously known for being the first person to see Jesus after his resurrection going to Jesus' tomb and finding it empty, and finally as playing an early Role in Early Christianity so she is often referred to as the "Apostle to the Apostles" because she was the one who brought the news of Jesus' resurrection to the other apostles. Mary Magdalene's legacy is continually honored in Christianity to this day.
- July 25th: The Feast of St. James the Greater, also known as James, son of Zebedee, was one of the Twelve Apostles of Jesus. He is distinguished as being part of Jesus' innermost circle, along with Peter and John. James was born and worked as a Jewish fisherman on the Sea of Galilee. he is often referred to as "the Greater" to distinguish him from another apostle, James "the Less," with "greater" meaning older or taller. James is known for witnessing several momentous events in Jesus' ministry, including the raising of Jairus's daughter, the Transfiguration, and Jesus' agony in the Garden of Gethsemane. He was the first apostle to be martyred, as he was beheaded by order of King Herod Agrippa I of Judea around 44 AD 2. Today he is recognized as the patron saint of Spain, and according to tradition, his remains are believed to be held in Santiago de Compostela in Galicia

Christians celebrate the following feast days worldwide and hold them in special significance in the Christian Church calendar.

In the United States, we commemorate significant secular holidays as well, including Independence Day, celebrated on July 4th, which is the day the colonists secured independence from England through the Declaration of Independence in 1776. It is a day filled with fireworks, parades, barbecues, and patriotic displays.

Historical Events, such as the Apollo 11 moon landing on July 20, 1969, and Bastille Day in France on July 14, 1789, which marks the beginning of the French Revolution, are joined by sporting events in July, featuring the Wimbledon tennis tournament in England and the Tour de France bicycling race.

So, enjoy the Summer Season, characterized by warm weather, vacations, and outdoor activities. It is a popular time for travel, beach outings, and family gatherings.





#### At the heart of every thriving school is a great teacher.

As the School District of Lee County prepares for the 2025–2026 academic year, we are proud to take the bold new step to honor and support the educators who are making the greatest impact on student achievement with the Honoring Our Educators: Teacher Incentive Initiative.

This initiative is not just another program—it is a strategic investment in the people who shape our future. Backed by the unanimous approval of the School Board of Lee County, this initiative establishes a new salary incentive structure designed to attract, retain, and reward high-quality teachers working in our most academically challenged schools and in subjects where their expertise is most urgently needed.

The goal is simple: to have high-quality teachers in every classroom on the first day of school in August. Our students deserve nothing less.

Across Florida and the nation, school districts are struggling to staff classrooms with certified, experienced teachers, especially in lower achieving schools and high-demand subject areas. Lee County is taking action. By launching this initiative, we are leveraging our legal authority under Florida law to make targeted compensation decisions that meet the needs of our students.

Here's how it works.

The initiative is built on an academic risk-based framework, identifying schools that face the highest academic and staffing challenges. Educators assigned to these schools with lower achieving students will be eligible for school-level salary incentives. These incentives, up to \$9,000, are on top of a teacher's base salary.

Additionally, the District has identified Critical and Complementary Subject Areas—specific courses and grade levels that are either directly tied to Florida's statewide accountability model or have a cumulative, measurable effect on student academic outcomes. Teachers whose schedules include a significant proportion of these subjects will receive additional incentives. Whether it's a high school Algebra teacher or a Kindergarten teacher, we are intentionally investing where it counts.

Critical Subjects include courses like Grades 3–10 English Language Arts, Algebra 1, Geometry, and Biology—subjects with mandatory state assessments and high vacancy rates. Complementary Subjects, such as early grade science or upper-level English, don't carry the same testing burden but play a key role in long-term academic achievement.

This dual-pronged strategy supports both immediate staffing needs and long-term student success. It's important to emphasize that this initiative is statutorily separate from collective bargaining.

While we remain committed to good-faith negotiations and value the work of our labor partners, this initiative stands alone under Florida law, allowing the School District to act swiftly and strategically in support of our educational mission.

Most importantly, this initiative sends a clear message: Lee County supports teachers taking on the critical challenge of prioritizing high student achievement for our entire community. We recognize that teacher quality is the most important in-school factor affecting student achievement. That is why we are not just filling vacancies—we're creating a system that recognizes the varying challenges our educators face within the classroom and ensures that every student has access to great instruction every day.

To our teachers: thank you. Whether you are closing learning gaps, guiding students through state standards, supporting students with disabilities, or nurturing curiosity in the earliest grades, your work matters more than ever. This initiative reflects our gratitude and our belief in the power of education.

This summer, take time to recharge and reflect on a year well spent. When school resumes in August, you will return to a District that is not only celebrating your success but investing in it.

Because in Lee County, we know that the future of education begins with you.





#### A SWAMP OF CONTROVERSY IN COLLIER COUNTY

A piece of Florida history was frozen in time; The Dade-Collier Training and Transition Airport—once heralded as the future site of the world's largest airport—now stands as a relic of grandiose ambition. Long abandoned by commercial aviation, its single, cracked runway has become the center of a new storm: a political, environmental, and humanitarian clash over a bold and controversial plan to convert the remote airstrip into a migrant detention facility, now chillingly dubbed "Alligator Alcatraz."

#### A Forgotten Runway, A Renewed Purpose

On a June morning, under the brooding heat of a subtropical sun, a convoy of trucks rumbled into the ghostly expanse of Dade-Collier. Satellite images, drone footage, and on-the-ground reports confirmed the presence of construction crews, cranes, and fencing materials—evidence that the project had been greenlit at full throttle. All hell was gonna break loose and the news lines will spike with all kind of weird stories and assumptions.

"This is a force multiplier," **Governor Ron DeSantis** declared at a press conference in Tampa. "We had a request from the federal government to do it — and so, Alligator Alcatraz it is." Like him or not - Once Ron clamps down on something it's a done deal.

The announcement sent shockwaves across the state. With federal immigration enforcement escalating and detention facilities elsewhere at capacity, Florida had stepped forward. The Everglades site, remote and controlled, was seen as ideal for housing up to 5,000 detainees, with a projected cost of over \$450 million annually. It was, in DeSantis' words, a "temporary solution" designed to support state and federal law enforcement.

But to many, it felt like the beginning of something more permanent — and more troubling.

The airport itself has a strange and storied history. In the 1960s, planners envisioned a cutting-edge "superport" capable of accommodating Concorde-style supersonic aircraft. It was



to be a marvel of engineering, the centerpiece of a booming Florida future. But environmentalists, Indigenous leaders, and local communities pushed back hard. By the 1970s, public opinion had shifted, and the ambitious plan fell apart.

The airport was never completed. Today, one lonely runway slices through a vast wetland wilderness teeming with wildlife: gators, herons, panthers, and invasive pythons. It's a place where nature reclaimed what human hands abandoned—until now.

#### **Environmental Flashpoint**

To environmental advocates, the new construction at Dade-Collier is an act of ecological vandalism.

"This proposal is not only deeply inhumane — but it is also profoundly irresponsible from an environmental, ethical, and fiscal standpoint," said Javier Estevez of the Sierra Club, standing before a crowd of journalists in downtown Miami.

Estevez pointed out the deep contradiction: How could the same administration that advocates for Everglades restoration justify building a detention center in the middle of one of the world's most sensitive ecosystems?

"The Everglades is not a staging area for mobile infrastructure," he said. "It's a fragile and irreplaceable ecosystem—central to our heritage and Florida's future."

## Cassie Testifies She Doesn't Hate Diddy Now, Has 'Love for the Past'

Nationwide — Cassie Ventura took the stand again on Friday in the federal sex trafficking trial against Sean "Diddy" Combs and made it clear she holds no hatred toward her former partner, despite the serious allegations she's made. During cross-examination, Diddy's defense attorney, Anna Estevao, asked her directly whether she hated the music mogul. Cassie calmly responded, "I don't hate him," before adding that she still has "love for the past and what it was."

TMZ reports that the exchange stood out as one of the few moments in which Ventura spoke about her current emotional state regarding Combs, with most of her nearly two-day testimony focused on the details of her harrowing allegations. Cassie previously filed a civil lawsuit against Combs in 2023, which was settled out of court just one day after it was filed. However, the federal government later brought forward criminal charges, leading to the current trial.

In her testimony, Ventura accused Combs of years of abuse, including rape, forced drug use, and being coerced into sex with male prostitutes while Combs watched. She alleges that the abuse began when she was just 19 years old and signed to his Bad Boy Records label. One of the most chilling moments she recalled was after their breakup dinner in 2018, when she says Diddy drove her home, entered her apartment uninvited, and raped her on the living room floor.

The defense has tried to poke holes in her credibility, focusing on inconsistencies and pressing her about why she maintained a relationship with Combs for so many years. They also questioned her about a supposed "closure" conversation she had with Combs following their breakup. Estevao used that line of questioning to ask whether Cassie still had emotional ties to her former partner, which led to Cassie's statement about loving the past. Despite the deeply traumatic

events she described,

Ventura remained composed on the stand. Her willingness to acknowledge that she still holds some affection for their shared history, while simultaneously detailing years of alleged psychological and physical abuse, presented a complicated emotional portrait to the jury.

Combs is currently facing charges that include sex trafficking, racketeering, and transporting individuals across state lines for illegal sexual activity. Prosecutors allege that he ran a decadeslong criminal enterprise using his fame, wealth, and influence to control and exploit young women. He has pleaded not guilty to all charges. The trial, which began earlier this month, is expected to continue for several more weeks, with more witnesses scheduled to testify.

Drone footage showing bulldozers plowing through sawgrass did little to calm public concerns. Ecologists warn that even temporary facilities risk polluting water tables, disrupting wildlife migration paths, and damaging protected species' habitats.

#### Garrett Stuart, director of the Eco

**Preservation** Project and a descendant of the Miccosukee Tribe, was even more forceful in his condemnation. "This site is sacred. It's where

Nixon stood when he declared that we needed to protect the environment," Stuart said, referring to the historic 1970s conservation efforts that eventually led to the formation of the Environmental Protection Agency. "To give this land over for cages and razor wire is like cutting off my own scalp and handing it to them."

#### **Cultural and Historical Reverberations**

About a mile from the site lies Indigenous land where Miccosukee traditions still thrive in airboat-access-only communities. These communities have long fought to protect the Everglades, not only as an environmental resource but as a spiritual and historical home.

Chokofa Billie, an elder in the Miccosukee Tribe, told local reporters, "We were here before the airport. We will be here long after it's gone. But what happens to the water happens to us. You can't separate the land from the

The proximity of the detention center to sacred sites has sparked protests and legal threats. Tribal representatives are consulting with environmental lawyers about the legality of building what some have called a "floating prison" on the edge of sovereign lands.

#### **Political Calculus and National Impact**

While Florida's state leaders present the project as a temporary and necessary response to national immigration pressures, critics argue it's also a political play — part of a broader narrative pushed by DeSantis and other conservative leaders.

"This is about optics as much as policy," said Dr. Angela Paredes, a political science professor at the University of Florida. "Alligator Alcatraz' is a name that evokes fear, control, and power. It's designed to resonate with a specific base that feels the federal government has lost control over immigration."

According to leaked planning documents obtained by investigative journalists, the facility will include several large prefabricated structures, tent barracks, medical units, and helipads for deportation transport. The fencing — topped with motion sensors and barbed wire — is being installed with round-the-clock security.

The documents also mention "minimum human contact" policies, suggesting a heavily automated or drone-monitored site. Civil liberties groups have already begun filing Freedom of Information Act (FOIA) requests to better understand how detainees will be processed, housed, and released or deported.

"This is a black site in the making," warned Emily Chen, a legal

analyst for the Florida Civil Rights Alliance. "No transparency, no oversight, and no easy access for family or legal aid. That's not a detention center — that's a human rights crisis waiting to happen."

#### **Community Reactions and Uneasy Silence**

In nearby Collier County towns like Everglades City and Ochopee, the reaction is mixed. Some locals welcome the increased economic activity, especially the promise of temporary construction jobs. Others fear what the presence of the facility will mean for their already small and isolated communities.

"My cousin just got a job working security," said one anonymous Everglades City resident. "He's got a family, and there ain't much work around here. But even he says it feels wrong."

Local businesses, many of which rely on eco-tourism and the image of the Everglades as a pristine wilderness, worry the detention center could drive visitors away.

"What are we supposed to tell people?" said Amelia Brooks, who runs an airboat tour company. "That they can see alligators by day and hear screams from a detention camp by night?"

#### **DeSantis' Defiant Stand**

Despite the uproar, Governor DeSantis has doubled down on the project. Speaking again just days after the initial announcement, he reiterated the temporary nature of the facility.

"This thing's been used a bunch of times over many, many years — and so the impact will be zero. That's in keeping with our policy," he said, referencing previous use of the airport site for military and training purposes.

But environmentalists, tribal leaders, and civil rights advocates aren't convinced.

"They say it's temporary," said Estevez. "But so was Guantanamo Bay."

#### A Swamp of Questions

As July matures and the facility nears operational status, questions abound. How will detainees be treated? Who will oversee the center? What legal protections will exist? What happens if a hurricane hits the site? How much environmental damage will be done before the first migrant even arrives?

And perhaps most troubling of all: Is this the beginning of a new era in immigration policy — one where remoteness becomes a tool for secrecy?

For now, the runway at Dade-Collier,

flanked by buzzards and cypress trees, is quiet. But soon, it will hum not with jets or tourists, but with the machinery of incarceration, powered by politics, fear, and the unforgiving sun of the Everglades.

"Alligator Alcatraz," as the governor calls it, may be temporary. But the scars it leaves — on the land, on the people, and on the soul of Florida — could last far longer.

I say give Rick LoCastro a chance to waltz through the myriad of information and give his findings to the public. We all know that Commissioner LoCastro is one of the best when it comes to resolving issues.



# Standing Up to the Bully: Harvard University's Battle Against Trump.

## (ThyBlackMan.com) The world is in greater peril from those who tolerate or abet evil than from those who do evil themselves. Albert Einstein

They say that when it comes to bullies, handing over your lunch money hoping they won't ask you again is never a good idea; you're just going to get mugged again and again. Reading the article "If Harvard, Armor-Plated by History and Padded with Funds, Can't Beat Trump, No One Can" (The Guardian) struck a chord within me. Here we have an American institution — Harvard! — an emblem of academic excellence and historical standing, standing up against the strong-arm coercion of Donald Trump. And it teaches us an important lesson about how to deal with bullies: stand up to, not roll over for, them.

Speaking as someone extremely blessed to have completed several Harvard classes via the edX platform, this hits home for me. I am the proud holder of certificates from courses hosted by HarvardX, Harvard University's online course initiative. To me, Harvard isn't just a name — it's a part of my journey as a lifelong learner. I wrote a children's book in 2021 titled: *Bringing Grandma Home!* This was at the height of the Covid 19 epidemic. A trusted friend suggested that I take a class being offered by Harvard Medical School for Medical Professionals. This was an attempt on my part to provide background information and credibility based upon the subject matter: Covid 19. Reluctantly, I took the class and was awarded a Certificate



of Completion that adorns my wall today. Bringing Grandma Home! was an Amazon.com bestseller and received a 5-star review from Readers Choice. Way to go Harvard! That connection makes me doubly proud and inspired to see this storied institution standing tall.

#### Standing Up to the Bully: Harvard University's Battle Against Trump.

The article which inspired this piece shows how the president's recent antagonism toward Harvard is only his most recent iteration of a broader Trumpian pattern: He looks for some influentially symbolic examples of the "elite" and then tries to take it apart for political advantage. It is a strategy that revolves around intimidation, disinformation and public spectacle. To Trump, institutions like Harvard are not just educational entities; they are ideological foes — organizations that question his grievances and narratives of victimhood.

Yet, Harvard isn't flinching. If anything, they are using their strong brand, litigation experience, and financial resources to defend instead of conceding or capitulating. This is critical. Because if Harvard (with its centuries of history, 56 billion in endowment, cache of influential graduates) can't withstand these bullying efforts... Then who can?

As a proponent of Diversity, Equity and Inclusion (DEI); one aspect that I especially admire is that Harvard is not apologizing for its diversity, equity and inclusion initiatives. Political pressure has caused many institutions to wither, retrench programs or offer empty apologies. But Harvard, true to its educational mission, knows that constructing a diverse academic community isn't political — it's principled.

It's easy to have a go when you are sitting behind the lectern. It's much more difficult to stand firm when powerful forces are trying to portray you as a member of some imaginary cultural axis of evil. Harvard's position calls to mind something I've come across time and again in reading and thinking over the years: integrity frequently requires taking a stand. A spirited stand for truth, knowledge and a level playing field for all to think and extend effort has more grit than capitulating to fear-mongering and ideological violence.

More broadly, Harvard's pushback is part of something happening all over America. Once it made sense to prefer an air of neutrality above the fray, institutions are increasingly acknowledging, neutrality in many aspects is no longer an option. In such a time, silence is complicity when our most cherished values of free inquiry, inclusivity and academic freedom are under assault.

In its behavior, Harvard is teaching others how to live with this new reality. It's not political games; it is a core principle. At the core, education is about changing. It surprises us with new information, combines elements in ways we never thought of, and can build bridges between cultures and life experiences. These are the very values that Trump, in one way or another, is attempting to overturn: that knowledge and understanding should be available to everyone and not simply to a group that happens to agree with his worldview.

Looking back on my experience with HarvardX courses, I've come to realize I was drawn to them not simply because they were from Harvard but because they were, in spirit if not in fact, Harvard courses. It challenged me to be thought-provocative, to be discerning of assumptions, and to be open to new ideas. Those online courses weren't afraid to pull punches; they called for serious work, the kind of reflection on what you wanted to learn and who you wanted to be

that happens in a real class. They were as close to the real thing of what education should be as anything I've experienced.

I take heart from Harvard's defense of that ethos. It gives me a sense that institutions (and also people) should be judged not just on what they do, but on their willingness to speak in defense of principle at moments of maximum hazard. The stakes are greater than even Harvard. When the most powerful institutions in the nation allow themselves to be bullied, it sends a chilling message to every elementary school, high school and college across the country. It says: "You are next." It threatens to incite further attacks, not only on the elite institutions, but on public education, on independent research, on free speech at every level. It actually begs a question of all those willing to compromise...Who's next?

The position of Harvard is a call to arms: We cannot allow this to happen. If we are graduates, if we are online learners, if we were admitted to practice law, if we are parents, if we believe in the power of education to change the world, we are all in this together. Bullies thrive in silence. For them, when fear defines action, they grow stronger. But when they are confronted with firm, principled resistance, they falter. The fact that Harvard refused to be bullied reminds me that no matter how powerful the bully, strength comes from standing your ground.

To me, this moment isn't simply about Harvard against Trump. It's about the sort of country we want to live in. Do we desire a society in which knowledge is free, open and alive—or one in which it's censored, restricted and controlled based on political whims? We all have a choice. Institutions have a choice. And as individuals, we have to rally around those who opt for courage over capitulation.?

For my part, I'll add this modest goal of my own: to keep learning, asking questions and kicking up dust — and doing whatever I can to inspire others who hear the hounds baying to do the same. And through platforms like edX, through conversations like we're having today and through every effort to celebrate and defend education as a public good. Kudos to Harvard University. I am in total agreement with political analyst Roland Martin who says, "If Donald Trump comes for an elite educational institution like Harvard today, he is coming for the HBCU's tomorrow." Thanks, Roland, for reminding us that doing the right thing is usually not the easy thing but is always the thing that matters.

Who's next to stand up? Let's hope it's all of us.

You've already lived through decades of change—childhood, marriage, career, raising children. That wisdom is a springboard for


continued growth and joy as a senior. Engaging in hobbies, volunteering, learning a new skill, or joining senior-centered classes can be deeply fulfilling.


