

We've stood strong together to make tough decisions while keeping the values of this city intact through every setback and challenge. That's what resilience looks like.

I want to take a moment to thank the people whose leadership and partnership have made our progress possible:

To our new City Manager Gary Young, and our new City Attorney, Matthew McConnell – thank you for stepping into these critical roles and bringing your expertise and advisement to Council. Thank you to City Clerk Patricia Rambosk for your continued service and diligence.

To our dedicated Council Members: Councilwomen Petrunoff, Councilwomen Penniman, Councilman Kramer, Councilman Christman, Councilman Barton, and Vice Mayor Hutchinson, I appreciate your continued dedication to our community.

To all the residents who volunteer their time to serve on our city boards and committees - thank you, your work is essential and delivers results for our community.

But most importantly, thank you to the residents of Naples, your



voices matter and your priorities are what drive the work we're here to do this session.

We're entering this session with clarity: Naples is growing, our region is changing, and we're called to lead with focus. But at the core of that is cutting through the red tape.

I am committed to continuing to take a hard look at our boards and permitting processes. Right now, residents, developers, and staff alike are frustrated, and not because of the rules themselves, but because the system feels slow and inefficient. And they're right. The process must work for the people it serves.

This session, I am committed to working with the City Manager, Staff, and Council on analyzing our permitting processes so that it saves time and money and removes unnecessary barriers. We will minimize steps. We will evaluate our interpretations. And we will push back against any bureaucracy that favors complexity over common sense and disregards public interest.

That starts with us BUT it does not end here.

Because more and more often, we're seeing decisions that come from Tallahassee and Washington, that are overstepping their place.

We are seeing egregious overreach. It is not the role of the state or federal government to dictate how Naples manages its growth, its safety, or its identity.

I will continue to advocate for and defend Home Rule because we know what works for our community. Naples should never be forced into a one-size-fits-all model of governance that ignores our history, our charm, or our future.

We've called on state leaders to take a hard look at what's burdensome and what's not, but have yet to hear back from them. Whether it's FEMA-level development requirements or preemption laws that threaten our ability to protect against flooding, our safety and resilience must come first.

Infrastructure is at the heart of that. Next November, we will ask our residents to consider a \$120 million ballot referendum or an increase in storm water fees—the largest infrastructure investment in our city's history. These funds will repair seawalls,

update stormwater systems, restore streets, and protect our coastlines.

We've already begun:

- The beach ends damaged by Hurricanes Ian and Milton are being repaired.
- Outfalls are under reconstruction.
- And we are moving aggressively to ensure that Naples is ready not only for the next storm, but for the next generation.

NCH broke ground on the Schulze Family Heart and Stroke facility and the city ended the use of fluoride in the water system.

Our dedication to change reflects our broader commitment to listening to residents and making decisions that reflect their values.

## But we can't do this alone.

We must work closely with Collier County and the state of Florida—especially when it comes to cleaning up our lakes, strengthening our environmental protections, and making sure Naples doesn't carry the weight of the watershed alone. Our residents pay both city and county taxes, and they deserve a government that listens to them and distributes funding more equitably.

We're also evaluating the impact of major events on neighborhoods, traffic, and quality of life with seasonal tourism surges. We're actively balancing the need for celebration with the need for calm, community-centered planning.

We've also raised public safety wages to remain competitive and attract the best to serve our community.

We're proud to have a thriving cultural economy, from the newly open Gulfshore Playhouse to the incredible renovations that were recently completed just across the street at The Naples Players, and the former Von Liebig Center transformation into the Naples Art Institute. These institutions are not only pillars of the arts, but they are drivers of small business and contribute to our economic engine.


And while we protect our neighborhood charm, we will also invest in our vibrancy.

# CHARLOTTE COUNTY RABIES ALERT

Charlotte County Animal Control, in coordination with the Florida Department of Health in Charlotte County, has issued a 30-day rabies alert following confirmation that a raccoon in the Washington Loop Rd/Trails End Drive area of Punta Gorda tested positive for rabies.

#### **ALERT AREA BOUNDARIES**

**East:** Hidden Valley Circle, Ridgeland Court, Trails End Drive, Palm Hammock Court, and all areas extending one mile east of Trails End Drive/Washington Loop Road.

**West:** Grayfox Road and surrounding agricultural areas, including all locations within one mile west of Trails End Drive/ Washington Loop Road.

**North:** Sunset Road, Serene Boulevard, and portions of Washington Loop Road, extending one mile north of Trails End Drive/Washington Loop Road.

**South:** Bronco Road, the Shell Creek Park community, and Hathaway Park, covering all areas within one mile south of Trails End Drive/Washington Loop Road.

This alert serves as a reminder that rabies is present in the wild animal population and poses a risk to unvaccinated domestic animals. While this alert is specific to the identified area, rabies can occur anywhere in Charlotte County, and caution is advised countywide.

#### **RECOMMENDATIONS FOR RESIDENTS AND VISITORS**

- 1. Ensure all domestic pets are vaccinated against rabies and vaccinations remain current.
- 2. Avoid contact with wildlife, particularly raccoons, bats, foxes, skunks, otters, bobcats, and coyotes.
- 3. Do not feed or attract wild animals by leaving pet food outdoors or unsecured trash.
- 4. Never adopt, handle, or attempt to rescue wild animals, even if they appear friendly or injured.
- 5. Secure homes and buildings to prevent bats from entering.
- 6. Report animal bites or scratches immediately to Charlotte County Animal Control at 941-833-5690 or the Florida Department of Health in Charlotte County at 941-624-7200.

If your pet is bitten or exposed to a wild animal, seek veterinary care immediately and contact Animal Control at 941-833-5690.

Report stray or suspicious animals to Animal Control for removal.

Rabies is a fatal but preventable disease.

Prompt action, vigilance, and responsible pet ownership are key to protecting families, pets, and the community.

It is piped into us via news apps, X, cable, radio, and so many other formats we'd run out of paper before the list concluded. This is why it isn't sufficient to say we are guilty only of inaction, because with all of it being fed to us, we've obtained a collective state of **AVOIDANCE** In some cases, this may manifest itself as collective

action of the least burden and efficacy.

What do I mean by that? Things like protests that make you feel good about attending, ease your conscience, and enable you to go right back into the passive assistance in the issues as a whole. Perhaps you are feeling that I am a being a bit cynical here, but I think the latest craze, the "No Kings" protest is an ideal example. It is funded by a Walmart Heiress primarily, it seems, for having their cheap source of goods (and profit margins) threatened by the current administration. Sure, the theme resonates, might even have a peppering of truth to it. While they might not be ethical, they sure aren't stupid. They know you won't show up to the "Protect Walmart Profits Margins" march, no matter how well poetically that might read. I'm not condemning anyone who went, but in the end, what

was the real point, rather than to keep us at each other's throats and to continue to be pawns on someone else's chessboard? Did it effect policy? If it did, did it help anyone of your fellow members of this great Republic? Did it lead to more jobs? Or just higher profit margins for an heiress?

This is the MUNDANE AVOIDANCE THAT LEADS TO THE

ACQUESCENCE TO FYL that I am talking about. How many of us have decided to "let it go" when we see something bad happening? How many of us have given up after even a significant effort to address a wrongful situation? How many of us may have been the recipients of someone else reaching out to address a wrong, that we, knowing the amount of work and that potential for a negative impact in our lives, shelved this attempt effectively shutting it down? Maybe you work at a call center, or in a compliance department, or human resources and you are reading this right now actively trying not to remember. I don't really blame you. I have tried to be one of the ones taking effective and prolonged action and I can tell you from my results, I find it a hard thing to advocate for as even our own legal system almost argues for allowing such things to continue in the

# noble names of "COMPROMISE" AND "REASONABLENESS".

This is truly the insipid nature of the evil we face in the modern world. It was one thing when it was a dark army in a field or a social movement with clear and unsettling goals, but now it is more like a slightly tinted syrup that flows around all of us. The change in the light is almost imperceptible day to day, likewise with the viscosity, until one day we are shocked awake by something only to realize we can no longer distinguish day from night looking at the sky and that we are so firmly cemented in place, movement seems impossible.



Here is to seeing each other at the breach in the wall someday.

Imagine them seeing themselves not as statistics, but as leaders in a lineage of excellence.

We don't have to wait for February to celebrate who we are. Let's make Black History a living, breathing, year-round experience—right here in Dunbar.



# THE DIVINE NINE: CULTIVATING THE NEXT GENERATION OF LEADERS

The Divine Nine—historically Black Greek-letter organizations that make up the National Pan-Hellenic Council—have always played a critical role in shaping the leadership, service, and civic engagement of Black communities across the country.

When young people see what's possible, they reach higher. When they're mentored by people who look like them and share their struggles, they believe deeper. And when they're given the tools to lead, they will surprise us all.





# RENEWAL GROWTH AND INTROSPECTION



Across the planet, September is a month rich with spiritual, cultural, and symbolic meaning as it marks transitions and transformations in both nature, religious, and personal lives. Not surprisingly, this month resonates with themes of renewal, growth, and introspection as it is seen as a period of change and preparation, bridging the golden days of summer and the quieter, cooler tones of fall.

The Christian tradition offers celebration on **September 8**, remembering the birth of the Blessed Virgin Mary, **September 14** celebrates the Exaltation of the Holy Cross honoring the cross on which Jesus Christ was crucified and recognizing the cross as a sacred instrument of salvation, **September 21** commemorates the Feast of St. Matthew the Apostle and Gospel writer, **September 29**: celebrates the Feast of the Archangels Michael, Gabriel, and Raphael.

As autumn begins at various times, there are differing ways to define the start of the season:

Meteorological Fall is based on the annual temperature cycle and the 12-month calendar starting on September 1 and lasting for about three months. Astronomical Fall is based on the position of the Earth relative to the Sun, and begins on the autumnal equinox, which this year is on September 22 at 2:19 PM ET.

## NOTABLE SPIRITUAL EVENTS FOR MAJOR WORLD RELIGIONS:

**Rosh Hashanah** is the Jewish New Year, which represents a time of spiritual reflection and new beginnings. It is also a period for self-examination and repentance leading up to Yom Kippur, the Jewish Day of Atonement.

**Mabon** is a pagan festival that celebrates the autumn equinox and is celebrated as a time of balance and reflection. It also marks the second harvest and is a time to give thanks for the fruits of the earth and to share them with others.

**Some Christians and retail outlets anticipate Christmas in September,** especially as the weather begins to cool down. September is also a time for family gatherings, gift-giving, and festive meals as Fall begins to take hold of weather patterns.

Finally, September is a transitional month seen as a metaphor for "letting go and preparing for" what is next, symbolizing the idea that all endings lead to new beginnings. These events are celebrated with various rituals and traditions, reflecting the rich spiritual heritage of each religion.

challenges. Smith's office, serving the 20th Judicial District, struggled with attorney retention due to budget constraints. While hiring attorneys cost about \$60,000–\$65,000, legislative funding only allocated \$50,000 per position, forcing Smith to draw on other parts of her budget to bridge the gap. The mismatch between actual labor costs and allocated funding placed strain on staffing—especially in higher-cost-of-living areas like Collier County, where housing expenses made salaries even more insufficient.

Despite hiring challenges and 25% turnover rates, Smith remained focused on ensuring that every person assigned a public defender receives **competent**, **vigorous representation**—even in a labor-short climate.

Kathy is in my opinion...an unsung hero in Modern Justice. Imagine this; against the backdrop of widespread funding limitations and rising demands, Kathy Smith embodies what it means to be a public servant in the truest sense: adapting to budgetary shortfalls with creative solutions, prioritizing fair treatment of the accused, investing in rehabilitation, and serving with integrity under pressure. The lives that hinge on fair representation—some at the brink of losing everything—are better because of her relentless pursuit of justice.

In times where defenders are overworked, underpaid, and overlooked, Kathy ensures no one slips through the cracks. Instead of letting budget crises define her office, she defines what is possible—when compassion meets innovation.

#### RELENTLESS ADVOCACY UNDER ADVERSITY

Despite facing significant funding cuts and staff turnover, she has shielded the constitutional right to counsel, ensuring

Zeigler served as the Department Historian for the American Legion Department of Florida during the 2024–2025 term. He is a member of the American Legion Post 192 in Fort Myers.


