

# Naples Airport Authority Bill

I'd like to clarify a mistake in a previous article, Protecting Local Control of the Naples Airport, regarding the Naples Airport Authority (NAA) Special Act bill and provide an update on its legislative progress. The earlier article incorrectly described the bill's status, and that information has since been corrected. This article aims to give a clear overview of where the bill currently stands and the next steps in the legislative pathway.

On September 15, 2025, the Collier County legislative delegation unanimously voted to advance the bill to the state level. It will now proceed to the relevant committees for review during the Florida Legislature's 2026 Regular Session, which begins in January. The session is scheduled to last a maximum of 60 consecutive days, unless extended by a three-fifths vote of both the House and Senate.

# **HOW THE BILL PROGRESSES AT THE STATE LEVEL**

After passing the local legislative delegation, a special act begins its journey through the Florida Legislature. First, it is filed in the House and assigned to committees that review its content and hold public hearings. Stakeholders, including city officials and residents, can provide input and suggest amendments during the committee process.

The bill was officially filed in the Florida House on October 27, 2025, as HB 4005. It's now waiting to be assigned to committees for discussion. A local bill is different from a regular bill because it doesn't need a matching bill in the Senate. It only moves through one side of the Legislature. Therefore, if the House committees approve the bill, it moves to the full House for a vote. If passed by the House, the bill bypasses the Senate committee process and goes straight to the full Senate floor for a vote. If the Senate passes the bill, it is then sent to the Governor, who may sign it into law, allow it to become law without a signature, or veto it. Once approved, the special act takes effect on the date specified in the legislation.

This multi-step process ensures careful review and opportunities for public input at every stage—from local approval to state oversight—before the law takes effect.

### LOCAL OVERSIGHT MATTERS

As the bill progresses, the City of Naples will continue to advocate for thoughtful and transparent dialogue that reflects the long-standing relationship between the Naples Airport and the community it serves.

Established in 1969, the Naples Airport Authority (NAA) was created by a special act of the Florida Legislature at the City's request to manage and operate airport property that is, importantly, owned by the City of Naples. Essentially, the act gave the framework for local control and management of the airport while keeping the City as the landowner.


I believe that local governance of city-owned property is a cornerstone of effective community stewardship. Local oversight ensures that decisions about land use, operations, and infrastructure reflect the interests and values of those who live and work in Naples.


While residents of unincorporated Collier County benefit from airport services, the airport itself is a City asset, the lease is held by the City, and the City bears significant responsibility for oversight and accountability. Expanding board representation to include non-city residents would dilute local accountability and risk decisions that do not reflect the priorities of city residents.

As the legislative pathway unfolds, the City will continue to monitor the bill's progress and engage constructively with state leaders to ensure that any future changes to the NAA's structure maintain this vital principle: local governance should remain in local hands. Naples has a proud tradition of collaboration between its residents, elected officials, and partners at every level of government. Protecting that tradition remains a top priority as this important discussion continues in Tallahassee.

# at North Naples Home after gunshots were allegedly fired over Infidelity and Divorce.

James Ricardo Ibarra, 42, was arrested after a SWAT standoff at a North Naples home on Kirtland Drive. The standoff followed a domestic violence incident in which Ibarra allegedly threatened his wife and children with a gun.

Details of the incident:

- **Initial dispute:** The incident began with an argument between Ibarra and his wife over divorce and infidelity.
- Violence and kidnapping: During the altercation, Ibarra allegedly kicked his wife in the chest, fired a gun near her head, and forced her into an SUV at gunpoint.
- Wife's escape: His wife managed to disarm him and escape from the vehicle. Ibarra pursued her, but she was able to jump a fence and get help from neighbors.
  - **Children's escape:** The couple's children, who had been hiding in a locked bedroom, escaped through a window after cutting the screen.

- **Crash and barricade:** After his family escaped, Ibarra crashed his vehicle into multiple cars and a building before barricading himself inside his home.
- SWAT standoff: When deputies and a SWAT team arrived, Ibarra refused to come out. He was also seen setting items on fire on a grill outside the home.
- Negotiations and arrest: Following several hours of negotiation, Ibarra surrendered peacefully and was taken into custody around 3 a.m.. He was later taken to Collier County Jail.

Ibarra faces multiple felony charges, including aggravated battery with a deadly weapon and aggravated assault with intent to commit a felony. Suicide notes were reportedly found inside the home.







# TO THE EDITOR:

I am writing as a concerned resident of Charlotte County to express my alarm over recent reports involving County Commissioner Stephen Deutsch and allegations that a 50/50 raffle may have been used to raise money for his reelection campaign—an act that, if confirmed, would constitute a clear violation of Florida election law.

This issue deserves close public scrutiny, as it raises serious questions about the ethical conduct of one of our sitting commissioners and the integrity of local governance.

According to reports, State Attorney Amira Fox has turned over evidence to the Florida Department of Law Enforcement (FDLE) after photographs surfaced that appear to show a 50/50 raffle taking place during one of Commissioner Deutsch's campaign fundraisers. The presence of campaign stickers on the raffle box and the appearance of the event being politically affiliated have led to significant concern among community members and legal experts.

Former State Attorney Steve Russell publicly explained that Florida law explicitly forbids candidates from using raffles or lotteries to raise campaign funds. "It very specifically says that raffles or lotteries are prohibited as a fundraising mechanism," Russell noted. These laws exist for a simple and vital reason: to prevent gambling-related fundraising from influencing the political process and to ensure that campaign financing remains transparent and accountable.

Commissioner Deutsch, when contacted by reporters, denied that his campaign conducted any raffle, claiming instead that "some groups conducted it and gave the money to various charities." However, this explanation does not resolve the troubling questions raised by the visual evidence or by the timing of donations reportedly made to his campaign on the same date as the fundraiser. If campaign branding was present on raffle materials and the event was clearly tied to a campaign function, it becomes difficult to separate the candidate's campaign from the activity itself.

Whether intentional or not, such an action would represent a serious lapse in judgment for any elected official. Candidates are responsible not only for the direct actions of their campaigns but also for ensuring that no event conducted under their name or for their benefit crosses legal or ethical lines.

This latest controversy comes only months after Commissioner Deutsch faced public backlash for reportedly using a racial slur during a county-related discussion, a matter that resulted in public apology and required management training. While that issue was considered resolved, the recurrence of ethical concerns involving the same official reflects a pattern that cannot be ignored. Charlotte County citizens deserve elected leaders who set examples of professionalism, integrity, and respect for the law.

Even if it is ultimately determined that Commissioner Deutsch's campaign did not directly profit from the raffle, the perception of impropriety alone is deeply damaging. Public trust in government depends not only on compliance with the law but on the consistent demonstration of ethical leadership. When officials blur the lines between campaign activity and legality—or even appear to—confidence in local institutions erodes.

It is therefore essential that the Florida Department of Law Enforcement pursue a full and transparent investigation into these allegations, and that the findings be made available to the public. The citizens of this county have a right to know whether any violations of campaign or gaming laws occurred and, if so, what consequences will follow.


Moreover, this moment should prompt reflection within the Charlotte County Board of Commissioners itself. Stronger internal guidelines may be needed to ensure that all campaign-related activities conducted by sitting commissioners are fully compliant with state law and free of any perception of impropriety.

Our local democracy depends on accountability and transparency at every level. Allegations like these cannot be brushed aside or treated as mere misunderstandings. If the evidence supports the claim that an illegal fundraising raffle occurred, appropriate legal and ethical measures should be taken. If not, then the community still deserves a clear, factual explanation that restores public confidence.

I urge The SWFL Chronical to continue reporting on this story and to hold our elected officials to the same standards of accountability they pledge to uphold. Sunshine is the best disinfectant, and the public deserves to know the full truth about this matter.

# WHY CHARLOTTE COUNTY COMMISSIONER DEUTSCH NEEDS TO GO!

### **DEAR CITIZENS OF CHARLOTTE COUNTY,**

There comes a moment in the life of every community when truth can no longer be deferred. When half-truths, evasions and betrayals — once buried under the polite chess of politics — claw their way into daylight and demand judgment. I write to you now because we have reached such a moment in Charlotte County: the moment when leadership must answer to the people it serves, when the fragile trust between elected officials and electorate must be mended or severed.

For months, whispers hardened into headlines, and headlines into incontrovertible evidence that Richard Deutsch, a man who promised open governance and collaborative stewardship, chose instead a path of concealment and misrepresentation. He lied to his fellow commissioners. He willfully abandoned the norms of collegial governance. He was stripped of critical assignments by a board that could no longer, in conscience, entrust him with the duties he swore to uphold. Those aren't partisan soundbites — they are facts that demand scrutiny and a civil, unwavering response.

What makes this betrayal so corrosive is not only the content of the falsehoods but the manner in which they were offered. A public servant who misleads colleagues corrodes the very mechanisms that allow our county to function. Committees are not ornaments of convenience; they are instruments of oversight and expertise. To be removed from them is not a petty reprimand — it is a clear, institutional refusal to accept misbehavior. It is the board saying, in effect: "We cannot trust you to carry out these responsibilities." That is extraordinary, and it should alarm every voter, regardless of party or prior sympathy.

Yet perhaps the gravest damage is the slow, insidious alienation that followed. Leadership does not blossom in isolation. It is cultivated in conversation, in the exchange of perspectives, in the hard work of negotiating differences and finding common ground. *Commissioner Deutsch's choices have not only cost him assignments; they have cost him relationships* — the essential social capital that allows the county government to navigate crises, to fund schools, to fix roads, to protect the most vulnerable among us. You cannot govern effectively from the margins, and when a commissioner isolates himself from the board, the entire county pays the price.

We must be clear about the consequences. We are not here to savor the downfall of any single individual. Public life invites scrutiny and accountability; it should not be a stadium for schadenfreude. But we are here to insist that behavior has ramifications. To permit dishonesty to pass without consequence is to accept erosion of civic norms. It says that officeholders may lie, sow distrust, and expect to continue as if nothing has happened. That is a corruption of the social contract between public servants and the public.

Let me be candid: Charlotte County is at a crossroads. Charlotte County deserves commissioners who are rigorous in the facts they present, transparent in their dealings, and humble in their recognition of public trust. Our priorities — from economic stability to environmental stewardship, from public safety to the integrity of local elections — hinge on a board that operates transparently, respectfully, and collaboratively. Anything less breeds dysfunction.

I do not intend, therefore, to indulge the fiction that this is merely a temporary lapse. The pattern of behavior — lying to colleagues, being stripped of duties, alienating fellow commissioners — is a pattern that matters. Patterns reveal character. They reveal whether a person will place ego above service, whether they will choose personal theatrics over the tedious, patient labor of governance. That is not an abstract judgment; it is a practical one with immediate consequences for every resident's daily life.

To those who are tempted to dismiss this as "politics as usual," I say: the stakes are too high. We cannot let cynicism be our political ethic. Our responsibility as voters is to demand better. We must insist that our leaders be measured by their fidelity to truth, their willingness to collaborate, and their capacity to repair the damage they cause. We must hold them to account not because we enjoy punishment but because we cherish the institutions that allow our county to flourish.

So what will I — and others who share this conviction — do in response? First, we will continue to bring the facts into the light. Transparency is not a slogan; it is a habit. We will ensure that citizens have full access to the record, to the minutes, and to the decisions that led to the board's actions. We will document, calmly and comprehensively, the steps that produced the board's loss of confidence — not to humiliate, but to inform.

Second, we will pursue a program of healing and repair. Mistakes, when acknowledged, can be the seeds of renewal. If any public servant wishes to rebuild trust, there is a path: full, unambiguous apology; a demonstration of concrete corrective steps; and sustained collaboration with colleagues and constituents. If those steps happen, we will judge them on their substance, not their spectacle. But absence of meaningful repair is not a neutral act — it is a renewal of past injuries.

Third, and perhaps most importantly, we will ask the voters to decide. Democracy is not a passive system; it is a participatory one. Elections are where the public weighs character and competence and casts a verdict. This upcoming election offers Charlotte County the chance to speak clearly. It is not merely about one man's future; it is about the future direction of our governance. Do we want leaders who prioritize transparency, humility and cooperation? Or will we tolerate conduct that undermines those very values?

To my fellow commissioners who endured the consequences of this breach, I offer solidarity. To the staff who were saddled with the fallout, I offer gratitude for their persistence in keeping the county functioning. To the citizens who have watched this drama with dismay and fatigue, I say: *your voice matters more now than ever.* Come to the meetings, read the records, ask the questions. We cannot repair what we will not examine.

Some will call this letter theatrical. Fine. Let it be theatrical if it wakes us from complacency. But do not mistake drama for vacuity. Behind every impassioned plea for accountability lies a simple moral and civic truth: leadership without honesty is an empty shell. A commission that cannot trust itself cannot be trusted to steward our schools, roads, emergency services and budgets.

I will stand, openly and firmly, for the values we need: truth, accountability, and the steady work of rebuilding trust. I will not nurture revenge — that is small and petty. I will fight for consequence and for the restoration of the institutional norms that make Charlotte County functional. I will ask voters to judge based on record, and I will respect their decision. That is democracy. That is duty.

In closing, let me be as simple and direct as possible: Charlotte County deserves better. You deserve commissioners who respect truth, who collaborate in good faith, who place the public interest above personal spectacle. If that means a political consequence for someone who chose otherwise, then so be it. The people will decide. And when they do, let them do so with eyes wide open, guided by the facts and by their best judgment.

Being the eldest living member of a family of priests, this experience has shaped my life journey. I learned many lessons from books and real-life experiences. From watching my father


as a child, making mistakes of my own as a young adult, and now as a priest myself, I have seen many changes. Every new chapter brings both uncertainty and possibility."







With a handful of SEC programs — including Arkansas, Tennessee, Ole Miss, and Kentucky — already showing interest, the race is on. The brothers have made it clear: if a school steps up and offers them as a package deal, they're ready to commit.

"If we can play together, we're doing it," Caleb said after Western's latest win. "We've been doing this our whole lives — one plays safety, one plays corner. It just makes sense."

At 6'0" and 190 pounds, Caleb Williams is the definition of versatility. He also has a 3.4 cumulative GPA. The Western High senior has lined up at strong safety, quarterback, running back, and wide receiver this season. But his best work — and his best future — is at safety.

Scouts rave about his football IQ and instinctive playmaking ability. One SEC evaluator went so far as to call him "the next Ed Reed," citing his ability to diagnose plays and punish receivers with highlight-reel hits.

"He's a ball hawk with the instincts of a pro," said one SEC scout. "When he breaks on a pass, it's over. And when he hits, people feel it. He's got that throwback toughness you just don't see anymore."

(He has a 3.6 cumulative GPA and wants to be a Maritime Lawyer) The 6'3", 185-pound junior is already built like an SEC defensive back, with the length and recovery speed to lock down top receivers.

Bryce recently announced he's reclassifying to graduate early, aligning his college timeline with his brother's. That commitment to staying side-by-side is rare — and it's one reason recruiters are paying attention.

At a national prospect camp in Colorado, Bryce's breakout moment came when he intercepted five passes in one day. That performance caught the eye of none other than Deion Sanders, who extended a scholarship offer on the spot.

"When Coach Prime noticed me — that was a dream," Bryce said. "But I've always said, wherever we go, we go together."

Bryce's frame and footwork have led some scouts to compare him to a young Patrick Surtain II — patient, technically sound, and confident in isolation coverage.

# SEC PROGRAMS ARE WATCHING — BUT ARKANSAS COULD LEAD THE WAY

According to multiple sources close to the family, Arkansas has emerged as a serious contender. The Razorbacks have been quietly evaluating both brothers, impressed by their tape and chemistry on the field.

For a program that prides itself on grit, culture, and player development, the Williams brothers fit perfectly. Caleb brings the energy and leadership; Bryce brings the size and coverage skill that's hard to find in high school corners.

"Arkansas has always had that underdog edge," one Florida-based recruiting analyst said. "The Williams brothers would fit that perfectly — two kids who play with chips on their shoulders, who love the game, and who just want to compete."

The Hogs have a chance to make a statement here — one that says Arkansas can compete with anyone in the SEC when it comes to finding and developing elite defensive talent.

## THE BOULDER FACTOR

Of course, Coach Prime isn't going to back down quietly. With Bryce already holding a Colorado offer and Caleb now on their radar, the Buffaloes could swoop in with a package deal of their own.

The brothers have made no secret of their admiration for Sanders, and the opportunity to learn from one of the greatest defensive backs in football history is tempting.

"Coach Prime told me to keep working — that my time will come," Bryce said. "If he offers us both, that's hard to pass up."

Still, the pull of SEC football is strong. The speed, the competition, the tradition — that's where the brothers see themselves proving they belong among the nation's best.

### WHY THIS PACKAGE DEAL MATTERS

Family connections in football aren't new — but they matter. The McCourty twins did it at Rutgers. The Griffin brothers did it at UCF. Chemistry, communication, and loyalty are built in. And in today's recruiting world, those intangibles can be as valuable as a forty-yard dash time.

The Williams brothers don't just bring two scholarships' worth of talent — they bring a defensive identity. Caleb is the enforcer; Bryce is the lockdown. Together, they're the heartbeat of a defense that could define a recruiting class.

# **BOTTOM LINE:**THE SEC IS ON THE CLOCK

The Williams brothers have made it clear: they want to play together. They're ready to commit to a program that values both — not just as individuals, but as a duo with the potential to lead a defense for years to come.

Arkansas has the chance to move first — and if the Razorbacks do, they could land two future stars before the rest of the SEC wakes up.

"We just want a place that believes in us," Caleb said. "If they believe in both of us, we'll give them everything we've got."

Two brothers. One dream. One opportunity. Now the question is — which SEC school will pull the trigger first?
