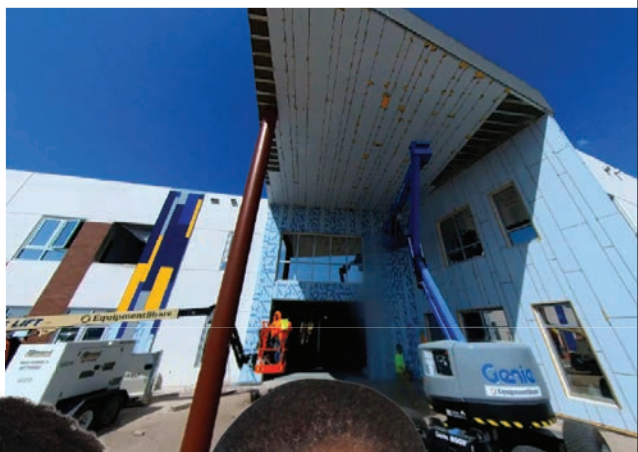

BRIDGING THE GAP CENTER FOR THE ARTS PRESENTS

In Living Color: A Juneteenth Art Experience

at Historic McCullom Hall

Bridging the Gap Center for the Arts (BTG Arts) invites the community to experience “In Living Color: A Juneteenth Art Experience,” a vibrant pop-up art exhibit celebrating culture, creativity, and community on June 19 from 6:00–9:00 PM at the Historic McCullom Hall. This free, all-ages event will feature visual art, live music, and local vendors in a space deeply rooted in Fort Myers’ cultural history.

At the heart of the evening is Featured Artist Rich Bravo, whose work is known for its bold use of color, expressive style, and ability to capture emotion and movement. Bravo is a mixed-media painter and illustrator whose work melds pop impressionism, surrealism, and chiaroscuro to create evocative, emotionally resonant visuals. With a growing presence in the regional art scene, Bravo brings a dynamic body of work that reflects both contemporary influences and cultural storytelling, making him a compelling highlight of this year’s Juneteenth celebration.

The exhibit will also showcase a diverse lineup of artists whose work spans conceptual art, sculpture, fashion, and mixed media storytelling.

Michael Pinckney, owner of PlexiMedia Group, is a musician and recording artist who has expanded into conceptual art, using found objects, symbolic text, and layered folk-like imagery to explore deeper universal truths through storytelling.

Ryna Sands — dancer, vocalist, actor, and artist — will showcase fashion art through her line, Crochet Couture By Ju, a crochet-designed clothing collection dedicated to the artistry of handcrafted, custom apparel pieces.

Recent FGCU art graduate Cheyanne Lewis developed a passion for creating triangular metal sculptures that highlight the beauty, strength, and resilience of the Black experience in spite of adversity.

Recent FGCU art graduate Ke’Siah Parsons creates layered, sculptural compositions that explore bold color, materiality, and emotional expression while reflecting community, connection, and shared lived experiences.

Guests will enjoy music by DJ Red Dog and a curated selection

of art, food, and drink vendors, creating an immersive and engaging atmosphere for attendees of all ages.

This event is presented in coordination with the Lee County Black History Society, STARS Complex, Dunbar Festival Committee, and Florida Repertory Theatre, as part of a broader weekend of Juneteenth celebrations across the community.

Bridging the Gap Center for the Arts is committed to cultivating artists and enhancing voices by bringing accessible arts programming directly into underserved communities. Through initiatives in theater, visual arts,

and creative expression, BTG Arts works to remove barriers and create meaningful opportunities for connection, growth, and storytelling.

“Hosting this pop-up exhibit at McCullom Hall is especially significant,” said Sonya McCarter, Founder and Executive Director of Bridging the Gap Center for the Arts.

“Once a thriving center for arts, music, and community gatherings, the historic venue holds a legacy of cultural engagement. In Living Color reactivates that spirit—bringing art back into a space where creativity once flourished.”

The event also reflects a growing trend in the arts world: pop-up exhibits in nontraditional spaces. By transforming familiar or historic locations into temporary galleries, organizations like BTG Arts are making art more accessible, inviting, and embedded within the community—meeting people where they are and reimagining how art is experienced.

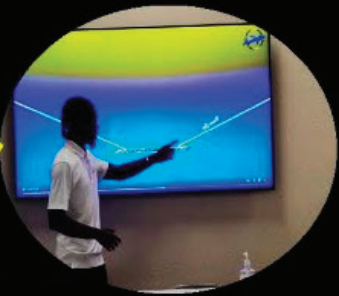

Our Children Cannot Wait:

The Literacy Crisis in Lee County Schools

District 4 candidate Gigi Gentile draws on her special education experience to address one of Lee County’s most urgent challenges.

Let me tell you about a student I once worked with. I will not use his name, but I will tell you this: he was in the fourth grade when I met him, and he could not read a single sentence independently. Not because he wasn’t intelligent. Not because he wasn’t trying. But because the early warning signs had been missed, the right interventions had never come, and by the time anyone paid close attention, he was already years behind.

That child’s story is not unique. It plays out in classrooms across Lee County every single year.

Florida’s literacy data tells a sobering story. And Lee County, despite real efforts and some genuine progress, has continued to struggle with reading proficiency — particularly in the early grades where the foundation is set for everything that follows.

“A child who cannot read by third grade faces an uphill battle for the rest of their education. That is not a statistic. That is a child’s future.”

As a special education teacher, I understand literacy challenges in a way that goes beyond test scores and data charts. I have seen what happens inside a child when they cannot keep up with their peers. The frustration. The shame. The slow erosion of confidence that, if left unaddressed, can follow a child well into adulthood.

I have also seen what happens when the right support arrives at the right time. It is transformational.

Here is what I will fight for as your District 4 school board representative:

First, full and faithful implementation of Florida’s READ Act — the state’s science-based, phonics-first literacy framework. The research is clear: structured phonics instruction works, and every Lee County school should be implementing it with fidelity and consistency.

Second, robust early intervention. We cannot wait until third grade to identify struggling readers. We need systematic screening in kindergarten and first grade, followed by targeted tutoring and support before children fall too far behind.

Third, real data transparency. Every family in District 4 deserves to know exactly how their child’s school is performing — in clear, accessible, school-by-school information published regularly and publicly.

And fourth, we cannot forget our advanced learners. Academic achievement means raising the floor AND the ceiling. Gifted students deserve as much attention and investment as students who are struggling.

Every child in District 4 deserves to leave school able to read, write, compute, and compete. That is not an aspiration. It is a promise.

SUMMER BREAK SPOT

Charlotte County Public Schools (CCPS) has announced the return of its Champ's Café Summer Break Spot program for 2026, ensuring that children throughout the community continue to have access to nutritious meals during the summer months when school is not in session.



Operating under the theme "Fueling Champions," the program reflects the district's ongoing commitment to supporting the health, well-being, and academic success of local students by providing free meals to eligible children and teenagers.

The Summer Break Spot program will offer complimentary breakfast and lunch to all children ages 18 and younger at participating locations across Charlotte County. Meal services are scheduled to run from June 8 through July 29, although some sites will begin serving meals earlier in June. Through this initiative, families can access healthy, balanced meals at no cost, helping to reduce food insecurity and ensure that children continue receiving proper nutrition throughout the summer break.

The program has proven to be a valuable resource for the community. During the summer of 2025, Charlotte County Public Schools served nearly 50,000 meals through the Champ's Café Summer Feeding Program. This significant number highlights the growing need for accessible meal services when schools are closed. The summer feeding initiative operates in accordance with federal program guidelines, which are designed to provide children with reliable access to nutritious meals during the months when regular school meal programs are unavailable.

One of the most notable additions to the 2026 program is the introduction of a seven-day bulk meal pick-up option. This new service is intended to provide families with greater convenience and flexibility by allowing them to collect an entire week's worth of breakfast and lunch meals in a single visit. The bulk meal option is especially beneficial for working parents, families with transportation challenges, and those who may find it difficult to travel to meal sites every day. By reducing the frequency of trips required to obtain meals, the district hopes to increase participation and improve access for families throughout the county.

To maximize community outreach and accessibility, meals will be distributed through a variety of service models. Families can receive meals through walk-in service at designated schools, public libraries, mobile feeding locations, and neighborhood bulk distribution sites. This broad network of service locations is intended to ensure that children from all areas of Charlotte County have opportunities to participate in the program.

A key component of the summer feeding effort is the Champ's on Wheels Mobile Feeding Bus. The mobile unit will operate Monday

through Friday, bringing meals directly into neighborhoods and community gathering spaces. While some service schedules will be adjusted on select dates during June, the bus will continue to provide an important connection between families and meal resources. Lunch-only service will be available at several stops, including the Port Charlotte Library from 10:30 a.m. to 11:00 a.m., the Mid-County Library from 11:30 a.m. to noon, and Hampton Point Apartments from 12:30 p.m. to 1:00 p.m.

Several schools throughout the district will also serve as meal distribution sites. Neil Armstrong Elementary School, Charlotte High School, Myakka River Elementary School, and Port Charlotte High School will provide both breakfast and lunch services Monday through Thursday during June. These locations will not offer meal service on Fridays during that month.

Additional meal sites will begin operating on varying schedules. Meadow Park will start serving breakfast and lunch on June 3 and will operate Monday through Friday, including service on June 15. Meanwhile, Baker Center will begin meal service on June 1 and will provide breakfast and lunch Monday through Thursday, along with special Friday service dates on June 5 and June 12.

Families interested in utilizing the new seven-day meal package option can visit designated neighborhood distribution sites between 11:00 a.m. and noon. Weekly meal pack distribution will take place on Mondays at Alfred and Jones Loop Road and on Tuesdays at the Charlotte Fairgrounds. These locations have been selected to make meal pick-up more convenient for families residing in different areas of the county.

It is important for families to note that there will be no meal service on Friday, July 3, in observance of the Independence Day holiday period. Participants should plan accordingly to ensure they have adequate meals during that time.

Charlotte County Public Schools encourages all families to take advantage of this valuable community resource. The district recommends reviewing the latest operating schedules, site locations, and program updates through the official Champ's Café Summer Feeding website before visiting a meal site. By offering free meals at multiple locations and introducing innovative distribution options, the Champ's Café Summer Break Spot program continues to play a critical role in supporting children and families across Charlotte County throughout the summer season.

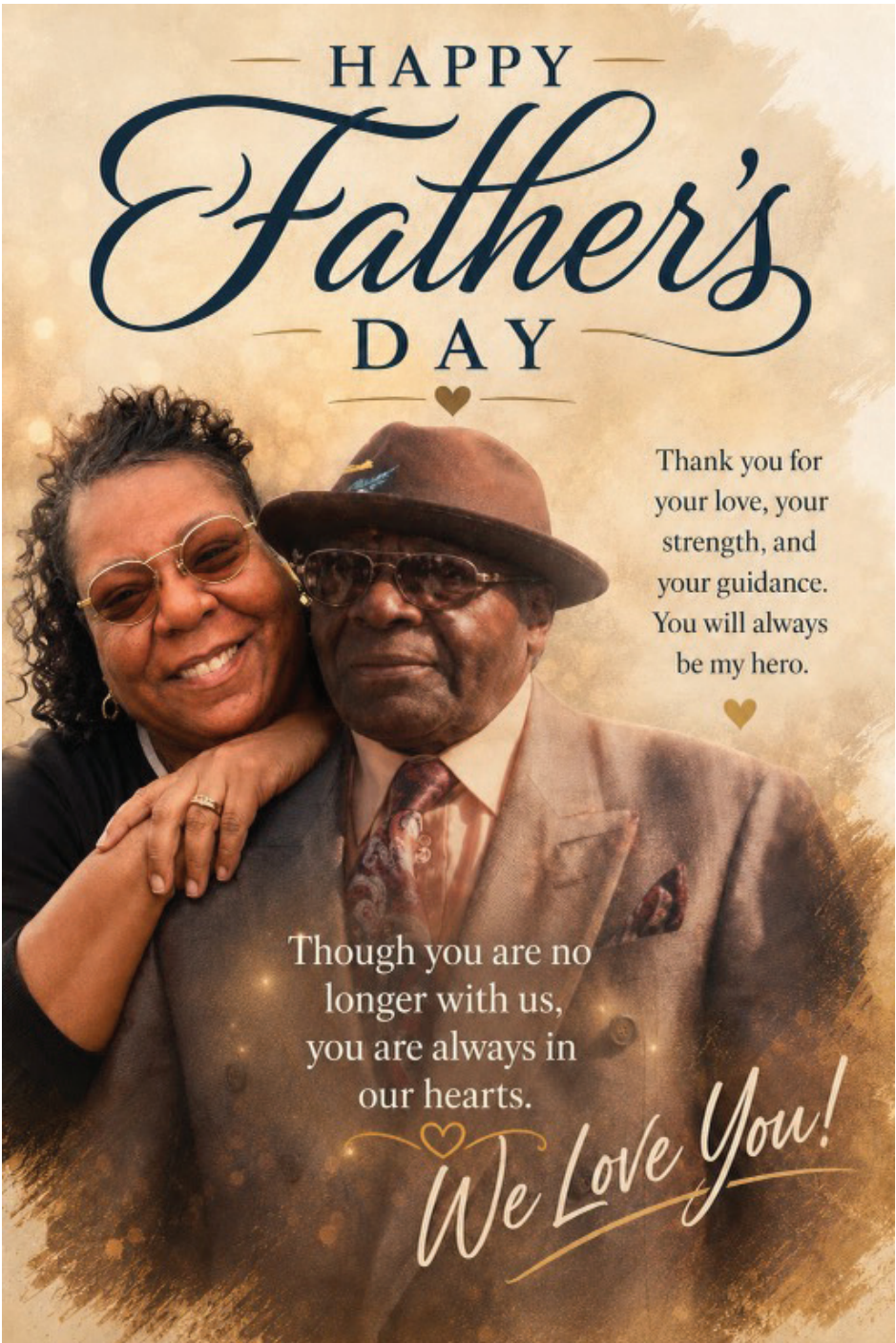
Since relationships are built on trust, we need to be careful of the “words” we say. If we constantly inconsistent with our words, we

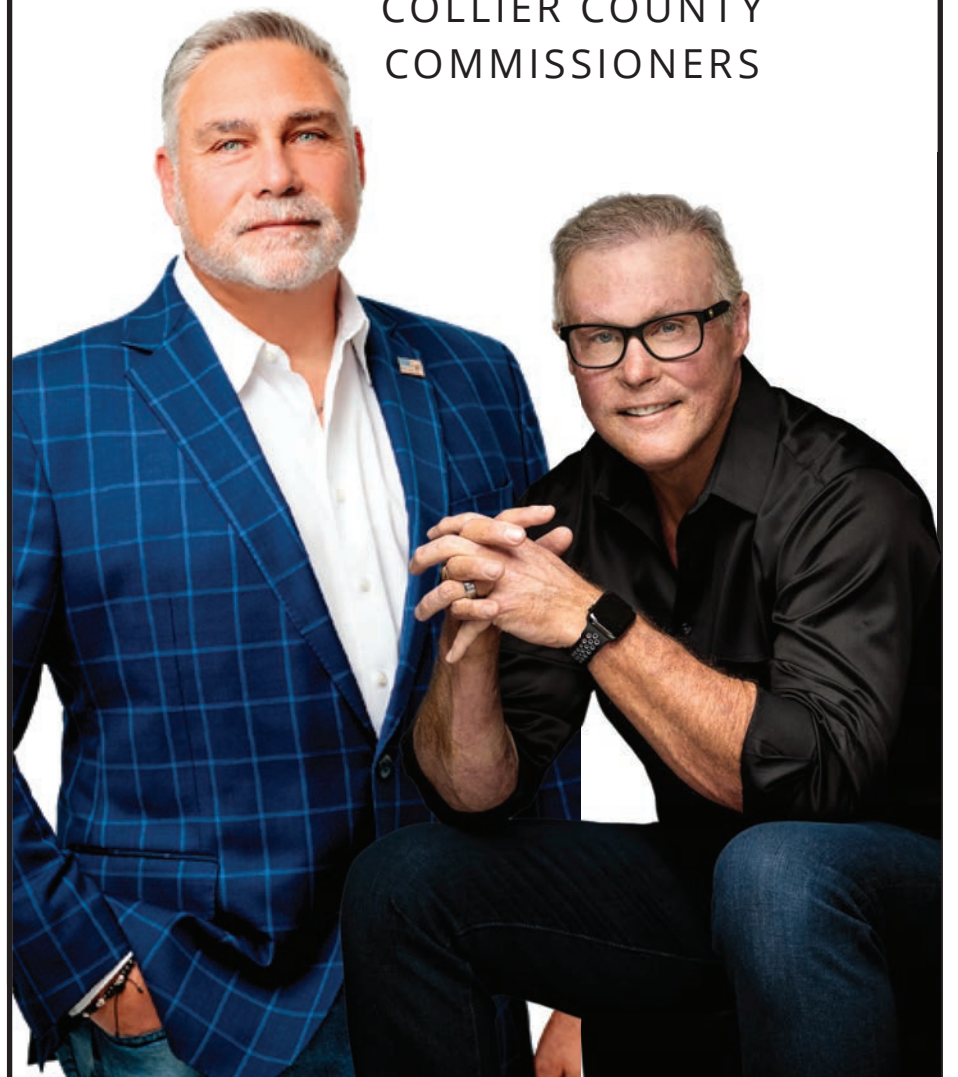

DEAR SOUTHWEST FLORIDA... LET'S HAVE 'THE TALK'

Recently the Florida school system has been rocked with several allegations of sexual misconduct involving teachers, coaches, and most recently a band director.

Although these kinds of indiscretions in education have existed for decades, with the 24-hour news cycle and social media, it is common throughout the nation to see a headline relating to an adult in education being accused of predatory behavior on his or her student(s). "They should have known better" is an easy response to any of the incidents regarding sexual misconduct of an educator towards a minor in their supervision, however I do believe it's time for all educational leaders to have "the talk" with their faculty and staff about safeguarding healthy relationships between adults and students in the school building.

INNOCENCE UNTIL PROVEN GUILTY

For almost two decades I have served as an educator and/or athletic coach, and it absolutely abhors me whenever there is a "breaking news" story of a teacher or coach under investigation for sexual misconduct or indecent liberties with a minor. Although there are some 'scum bag' individuals easy to identify within the profession who have been charged or convicted of being predators, there are others who were respected professionals who would have never aroused such a suspicion. Unfortunately, in the court of public opinion only three kinds of people make headlines whenever they are accused of a crime: politicians, entertainers, and educators.

As tempting as it may be to 'cast the first stone,' I still want to remind readers of this op-ed that even teachers and coaches deserve the courtesy of being 'innocent until proven guilty.' In 2023 an article written by Matt DeGrood for the Houston Chronicle titled How a False Allegation Changed a Former Cy-Fair Coach's Life, DeGrood highlighted how a coach lost his career and had his reputation ruined over a false allegation from a female student. Additionally, former Georgia Tech head men's basketball coach, Josh Pastner was a victim of an extortion plot by a woman who threatened to falsely accuse him of sexual assault. For these two reasons, and many others, I encourage readers to allow any allegations of sexual misconduct to have a process of completion before rendering any judgment.

NOT A NEW PHENOMENON

While Mary Kay LeTourneau was making national headlines for her unapologetically sick sexual assault on one of her middle school students in the late 90s, I can remember a former high school coach from my hometown being perp walked out of his classroom over allegations of an inappropriate sexual relationship with one of his students. However, because the incident only garnered local news, and I do not believe the parents pursued any justice, it was summarily 'swept under the rug.'

I would argue that most teachers and coaches have worked with a colleague who has either been suspected, or convicted, of some kind of sexual misconduct involving a minor. One of the most recent incidents here in Florida was only reported because of CS/HB 495: K-12 Public Education was signed by then Governor Rick Scott in 2018, which summarized that a teacher or coach could be charged with sexual assault, even if the victim consented and was 18 years of age. Veteran teachers and coaches have a moral obligation to correct novice teachers and novice coaches whenever there is a recognized potential of the latter crossing personal boundary lines with their students or players.

WHAT CAN SCHOOLS DO TO SAFEGUARD THEMSELVES... HAVE THE CONVERSATION!

"They should have known better" is a sensible response whenever there is a report of a teacher or coach being arrested for sexual misconduct involving a minor. However, novice educators are being set up to fail by their post-secondary institutions and their districts through mis-prioritizing this historical problem. I am asking for both school districts and post-secondary training institutions to consider developing curriculum on this topic because 'they should know better' can no longer be the only sufficient response!

Below are five simple steps I believe every teacher and coach should consider about their environment as a supervisor of students and athletes:

1. Always, if possible, keep the door of the classroom open when alone with a student; especially, if it is a student or athlete of the opposite sex
2. When transporting a student alone, make sure the ride is always recorded (recommended for coaches)
3. Avoid having social media interaction with current students and/or players
4. Removing oneself from any social setting where current students and/or athletes frequently attend
5. Never disclose relationship matters in detail to students and/or athletes

Unless someone has a historical pattern of predatory behavior prior to entering the education profession, very few, if any, teachers or coaches who have been convicted of sexual misconduct towards students start their careers with the intention of being a child sexual assaulter. Some convicted teachers or coaches turned sexual predators have blamed failed adult relationships, persistent student-initiated flirtation, or being 'caught in the moment' as reasons for their indiscretion. However, there is no excusable reason for an adult in a supervisory role to sexually abuse and violate the most innocent of our society. If the worst outcome of my five suggestions is nothing, then so be it; nonetheless, educational leaders having these discussions in their trainings might prevent a teacher or coach from losing their career, or worse, their freedom.

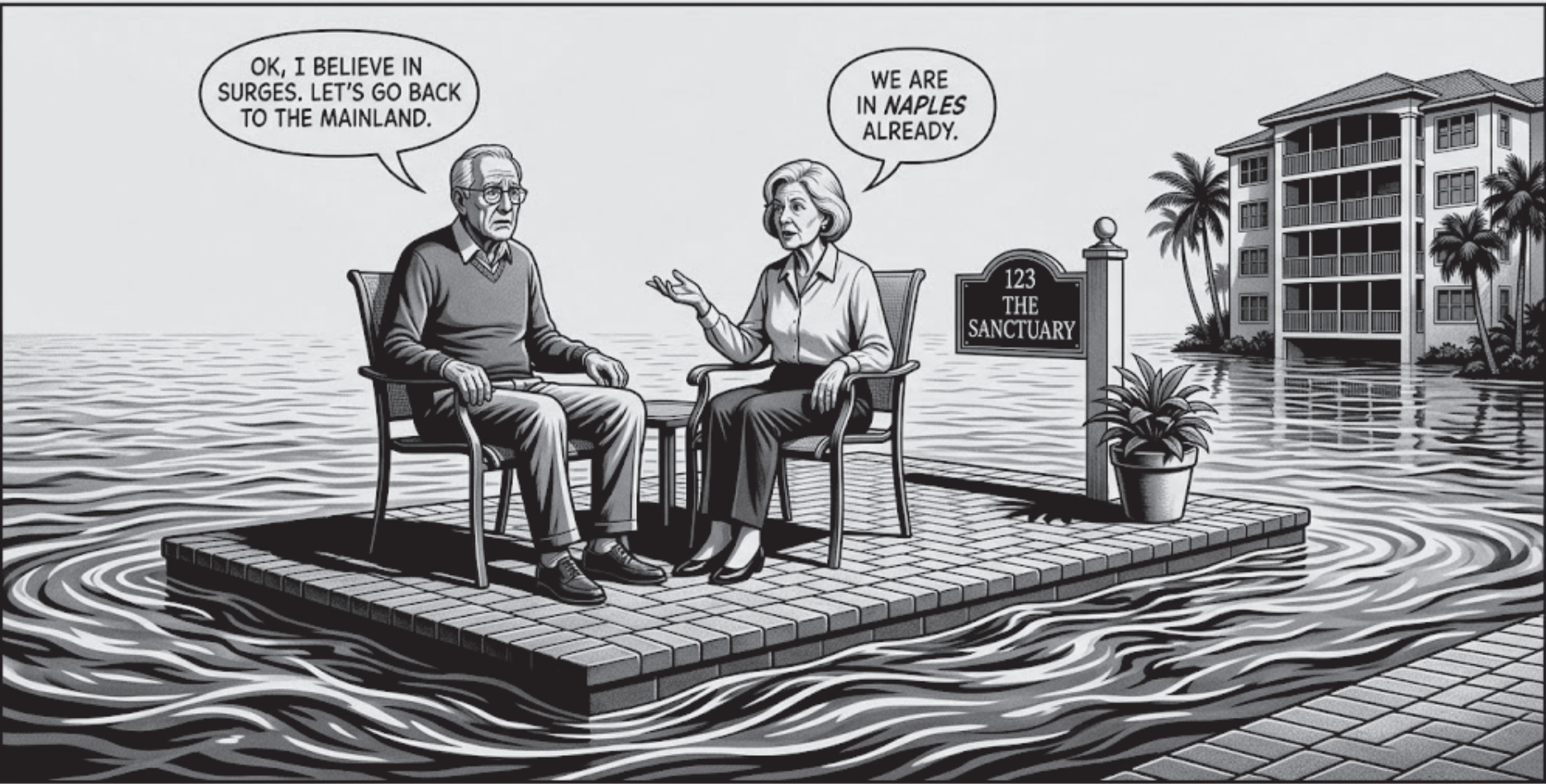

Less than a year after its high-profile launch, Florida’s border enforcement experiment, the South Florida Detention Facility or “Alligator Alcatraz,” has crashed and burned. Touted by Governor Ron DeSantis and Representative Byron Donalds as a tough, fiscally responsible migrant deterrent, the operation became a textbook example of political overreach meeting logistical and financial catastrophe. The abrupt June 2026 shutdown follows months of chaos, unpaid debt for Florida taxpayers, and a definitive legal defeat over civil rights and

catastrophic contractor insolvency, leaving vendors unpaid and halting supply networks and facility maintenance. Exposed ICE contractors are now positioned to sue the state for massive breach-of-contract damages. Federal courts simultaneously stripped the site of legal viability through injunctions over civil rights and environmental violations. The remote, toxic location also decimated the workforce. Guards at the isolated Dade-Collier airport wasteland faced punishing heat and swarms of mosquitoes. Aggressive,

to halt the discharge of chemically contaminated wastewater, arguing that relentless light pollution from 24-hour security illumination infringed on its sovereign hunting rights. Attorneys from Earthjustice and the Center for Biological Diversity proved that this pervasive light pollution and unpermitted infrastructure dismantled critical habitats, threatened the region’s dwindling panther population, and forced an immediate end to the failed project. The closure of Alligator Alcatraz was a political embarrassment to Secretary

environmental negligence. The political chest-thumping surrounding the July 2025 launch has degraded into rapid damage control. DeSantis, who championed its hostile footprint in the Everglades as an unyielding deterrent, has inverted his narrative, now claiming the encampment was temporary. The closure stems from severe financial bleeding, costing an unsustainable \$1.2 million per day. The state expected federal reimbursement for the \$600 million spent on operations, but Washington refused to pay, forcing Florida taxpayers to absorb the loss. This fiscal strain triggered

continuous mosquito spraying exposed personnel to hazardous chemical vectors, compounding a volatile internal culture—reports detailed operational rot and physical brawls. The collapse left local ICE personnel and emergency management staff stranded and exposed to personal liability. Local and national civil rights and environmental groups banded together to sue Florida. Friends of the Everglades Executive Director Eve Samples exposed financial underreporting, with internal spending projections hitting \$1.4 billion. The Miccosukee Tribe litigated

Noem and Trump, which has led to her being sidelined to an invented agency. It is a fiscal and environmental disaster. After burning through \$1.2 million per day, the facility leaves behind hundreds of millions in state debt, exposed contractors ready to sue, and legally vulnerable local personnel. Most critically, the project failed because it ignored fundamental environmental and constitutional law, with relentless light pollution and chemical spraying harming ancestral Miccosukee lands and the Florida panther population.

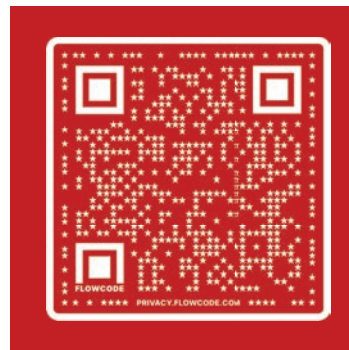

ETF's - a simple and smart way to Invest

I wanted to share some thoughts with you about investing, especially about something called **EXCHANGE TRADED FUNDS**, or **ETFs**. Many people hear complicated financial terms and immediately feel confused or nervous. The good news is that ETFs are actually one of the simplest and smartest ways for ordinary people to invest money over time.

An ETF is basically a basket of investments. Instead of buying shares of just one company, an ETF allows you to own small pieces of many different companies at once. Some ETFs include hundreds or even thousands of companies. This is important because it spreads out your risk.

For example, imagine you put all your money into one company and that company struggles or goes out of business. You are up the creek without a paddle. You could lose a large amount of your investment. But if your money is spread across many companies through an ETF, one company performing badly will not hurt your investment as much. This is called *diversification*, and it is one of the biggest advantages of ETFs. Especially for beginners.

Another reason ETFs are a good investment is because they are simple to buy and sell. ETFs trade on the stock market just like regular stocks. *You can buy them through most investment accounts, retirement accounts, or online brokerages. This makes them very convenient for beginners and experienced investors alike.*

ETFs are also known for having low costs. Many mutual funds charge high management fees because professional managers actively choose investments. ETFs, especially index ETFs, usually cost much less because they simply follow a market index like the S&P 500. Lower fees are very important because high fees can slowly eat away at your profits over time. Even a small difference in fees can make a huge difference after many years of investing.

One of the best things about ETFs is that they allow everyday people to invest in the overall economy. Historically, stock markets have grown over long periods of time. While markets go up and down in the short term, they have generally

earning returns too. Over many years, even small monthly investments can grow into substantial savings.

For example, someone who invests consistently over 20 or 30 years may build significant wealth, even if they never earn a huge salary. The key is patience and consistency. ETFs make this easier because they are affordable and easy to manage.

ETFs are also transparent. Most ETFs clearly show what investments they hold, so investors know where their money is going. This transparency can give people confidence and help them better understand their investments.

Of course, no investment is completely risk-free. ETF values can go down during market downturns, recessions, or economic uncertainty. Investors must be prepared for temporary declines. However, many financial experts believe that long-term investing in diversified ETFs is one of the safest and most reliable ways to build wealth over time.

One important lesson about investing is that time in the market is usually more important than trying to perfectly time the market. In other words, consistently staying invested for many years is often more successful than constantly buying and selling based on short-term news. ETFs are ideal for this long-term approach because they are designed for steady, diversified investing.

In my opinion, ETFs are one of the best investment tools available today because they combine simplicity, low costs, diversification, and long-term growth potential.

They make investing accessible to regular people who may not have advanced financial knowledge or large amounts of money to start with.

The earlier someone begins investing in ETFs, the more time their money has to grow. Even small investments made consistently can become meaningful over the years. Some focus on large American companies, while others invest in international markets, bonds, technology, healthcare, energy, or dividend-paying companies. This gives investors the ability to build a portfolio that matches their goals and comfort level.

For retirement savings, ETFs are especially useful. Many people regularly invest a small amount every month into ETFs through retirement accounts. Over time, this creates the power of compound growth. Compound growth means your money earns returns, and then those returns begin

Do Performance-Enhancing Drugs Prolong Athletic Careers?

The inaugural Enhanced Games, scheduled for May 2026 at Resorts World Las Vegas, shifts the performance-enhancing drug (PED) debate from temporary performance spikes to athletic longevity. Operating outside World Anti-Doping Agency (WADA) jurisdiction, the event legalizes medically supervised pharmacology to test whether chemical intervention can extend the operational lifespan of aging or sanctioned athletes.

The roster features two Florida natives whose trajectories challenge traditional retirement timelines: sprinter Marvin Bracy-Williams and swimmer Megan Romano.

For many elite competitors, career termination stems from regulatory sanctions rather than biological exhaustion. Marvin Bracy-Williams, an Orlando native and 2022 World Athletics Championship silver medalist, is serving a 45-month U.S. Anti-Doping Agency (USADA) suspension through November 2028. Under traditional frameworks, this enforced inactivity would compel the 32-year-old into permanent retirement. Enhanced Games offers an alternative to administrative closure, helps you stay competitive, and can lead to multi-million-dollar compensation.

In short-course swimming, athletic decline accelerates after the mid-twenties due to diminished explosive power. St. Petersburg native and four-time World Championship gold medalist Megan Romano, 35, enters the 50-meter and 100-meter freestyle events as the first publicly identified female participant. Romano utilizes the permissive framework to contest standard retirement curves, targeting pharmaceutical optimization to rival her past peak metrics.

The competition relies on three primary compound classes to counteract age-related degradation: **anabolic steroids** to accelerate protein synthesis, **Human Growth Hormone (hGH)** to fortify connective tissues, and **Erythropoietin (EPO)** to expand hematocrit levels and sustain aerobic output.

While organizers argue these interventions optimize biology, anti-doping authorities emphasize the structural trade-off. The long-term risks—cardiovascular hypertrophy, hepatic stress, and endocrine disruption—indicate that while pharmacology temporarily prolongs competitive windows, it induces severe post-career systemic toxicity.



Dear Brothers and Sisters,

We are living in a time where it feels like everybody is being pulled apart. In other words, unity reflects the heart of God and creates an atmosphere filled with peace, joy, and purpose. The word "brethren" goes beyond family ties and points to a larger community of believers connected by faith, love, and shared purpose. David encourages people not just to visit unity occasionally, but to dwell in it and live in it daily. In a culture where people are quick to disconnect, cancel, or isolate themselves, this message challenges us to stay connected, pray together, worship together, and support one another through every season of life.

Psalm 133 goes on to compare unity to the oil poured over Aaron the priest, symbolizing the anointing and blessing of God flowing freely among His people. It also compares unity to the refreshing dew of Mount Hermon bringing life to dry land. The message is clear: where unity exists, God sends renewal, healing, strength, and fresh vision. Many of us are searching for peace, breakthrough, and hope, but sometimes the answer is found in reconnecting with one another and returning to God together. The truth is, we are stronger together than we are apart. Previous generations survived hardship because they stayed unified in faith, prayer, and perseverance. Now it is our turn to carry that same spirit forward. Because when people come together in God's presence, burdens become lighter, faith becomes stronger, and lives can truly be changed. Unity still matters and there is still power in being "Unified In His Presence."
